Dear Steve:

We reviewed your proposed traffic detour for the replacement of the Gehman Road railroad crossing and find it acceptable. Please note that the all signs, lights and placement locations must conform to PennDOT Publication 212 and 213. Based on your fax, we understand that the detour route for this work will consist of Alburts Road (S.R. 3002), Schoeneck Road and Mountain Road (S.R. 2018) and the replacement of the crossing is scheduled to take place between June 22, 2009 and June 26, 2009. Please note that Schoeneck Road is owned and maintained by Lower Macungie Township.

Based on my conversation with Public Works, this letter will serve as your notice that the Township hereby grants permission to use Schoeneck Road to detour traffic around the work area on Gehman Road. Please post the necessary traffic control signs to notify motorists one week in advance of the road closure and notify Lower Macungie Township at least two (2) business days prior to the closure of Gehman Road so that the Township can notify its emergency services.

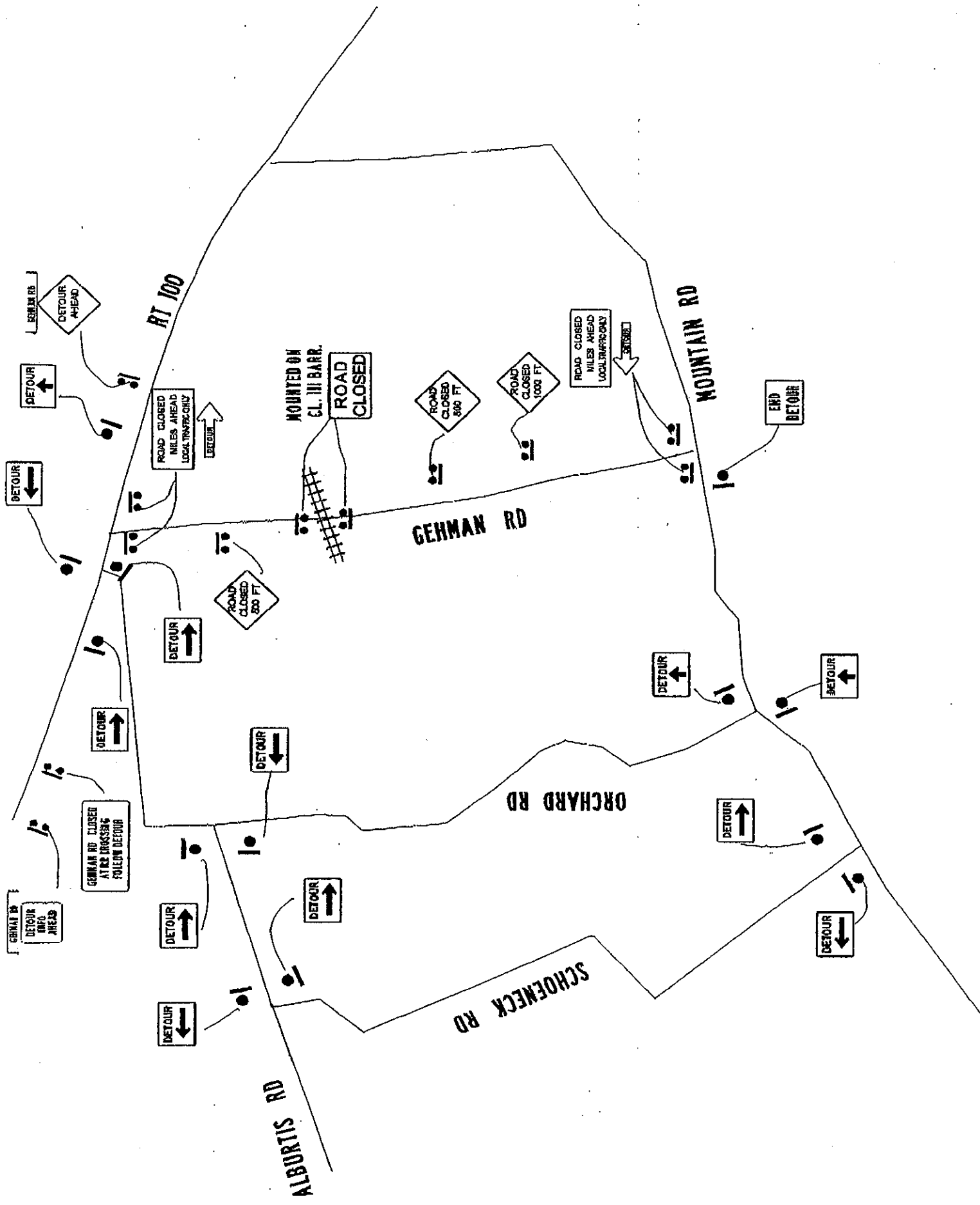

We reviewed your proposed traffic detour for the replacement of the Orchard Road railroad crossing and find it acceptable. Please note that the all signs, lights and placement locations must conform to PennDOT Publication 212 and 213. Based on your fax, we understand that the detour route for this work will consist of Alburdis Road (S.R. 3002), Schoeneck Road and Mountain Road (S.R. 2018) and the replacement of the crossing is scheduled to take place between June 15, 2009 and June 18, 2009. Please note that Schoeneck Road is owned and maintained by Lower Macungie Township.

Based on my conversation with Public Works, this letter will serve as your notice that the Township hereby grants permission to use Schoeneck Road to detour traffic around the work area on Orchard Road. Please post the necessary traffic control signs to notify motorists one week in advance of the road closure.
